1. Registration for the Summer Dance Academy is binding.
2. The journey is organized by the participants themselves.
3. If the minimum number of participants is not reached, the dance classes can be canceled by the Summer Dance Academy.
4. We reserve the right to make necessary changes to the information in the program. If necessary, they will be communicated to the participants by e-mail.
5. The design of the dance classes, the selection of the dance teachers and the selection of the music are the sole responsibility of the Summer Dance Academy.
6. Participation in the Summer Dance Academy is voluntary and is at your own risk.
7. The Summer Dance Academy assumes no liability for damage to property or financial losses caused by accidents during the events, on the way to or from the event, or during the entire stay. Liability is excluded for damage in connection with third-party services.
8. Withdrawal is not possible, as a binding place is reserved.  
I am aware that a travel cancellation insurance must be taken out for any unforeseen events.
9. The booked place is not transferable to another person.
10. In the event that another person pays the fees, this person (account holder) is jointly and severally obliged to pay the fee by providing his/her signature.
11. In the case of returned direct debits by your bank, a return debit fee of €10 will be charged.
12. The group discount expires and will be calculated retrospectively if a group member reduces the number of participants due to non-payment and the group no longer comprises 4 people.
13. Early bird prices expire in the event of return debit or non-payment and the price applies after 12/31/2023.

Dear parents,

In recent years there have never been any problems with under-18-year-olds at evening events etc. As the Summer Dance Academy promises intensive physical activity, your children will certainly not feel the urge to leave the facility in the evening. Of course, like every year, we will also organize evening events. Please talk to your child about proper behavior during the Summer Dance Academy.

Parental declaration for under-18-year-olds:

Our child is allowed to visit the public swimming pool alone (approx. 400 m from the facility).

Our child may take part in all evening events of the Summer Dance Academy.

We informed our child that unauthorized leaving the facility at night is not permitted and that the Summer Dance Academy does not accept responsibility for this. Under 18-year-olds who do not follow these rules will be excluded from the Summer Dance Academy and will have to be picked up by their parents. A refund will not be made.

We informed our child that violating the rules of the Summer Dance Academy could result in immediate exclusion.

We informed our child that it is expressly forbidden to bring and drink high-proof alcoholic beverages. There is a general ban on alcohol and smoking for under 16-year-olds.

We give our consent that our child may be provided with any medical care if it is necessary.
